DEADLINES

The Muskegon County Homeless Continuum of Care Network will accept and consider proposals from organizations that have not previously received CoC funding. The MCHCCN will not be re-allocating funds during this funding cycle. New applications must therefore submit applications for CoC Bonus or domestic violence bonus dollars.

July 31, 2024	HUD released the CoC Program Competition NOFO
August 15, 2024	Local timeline posted on Muskegon CoC website and sent to membership with local application and scoresheet
August 29, 2024 at 3:00 pm	Deadline for new and renewal project application submissions. Submissions must be sent via email to: madison@unitedwaylakeshore.org
September 10, 2024 at 9:00 am	Review and Allocation Committee Meeting – projects will be reviewed and ranked. Applicants may attend to answer questions
September 12, 2024 at 8:30 am	Steering Council Meeting – to confirm decision of Review Committee
September 20, 2024	Applicants notified of the approval status. If a project is rejected, there is an appeal process, and a solo application can be submitted
September 21, 2024	Certificates of Consistency are sent to the City of Muskegon for the Mayor to sign
September 25, 2024 at 3:00 pm	Appeal of a decision of the Review Committee or the Steering Council must be filed by send an email to: madison@unitedwaylakeshore.org
September 30, 2024	Appeal will be heard by Steering Council
October 1, 2024	Applicant will be notified as to the status of the appeal process. A solo application can be submitted by the appellant
October 2, 2024	Certificates of Consistency are signed by Mayor of the City of Muskegon

October 10, 2024	Steering Council meets reviews and approves CoC Collaborative Application
October 10, 2024	Posting of the notification to the applicants as to whether their projects were accepted or status of the appeal process on Muskegon CoC website
October 11, 2024 by 5:00 pm	Applications must be submitted in eSNAPS for the Collaborative Applicant to review *DO NOT HIT THE SUBMIT BUTTON – CORRECTIONS CANNOT BE MADE
October 16, 2024	Collaborative applicant – the United Way will send notices to applicants if any corrections are to be made
October 23, 2024 by 5:00 pm	Corrections are to be made by the applicants
October 25, 2024	Collaborative Application, Priority Listing is submitted to HUD
