Purpose and General Instructions

Purpose

The Supportive Services Analyst will provide email confirmation of receipt by the stated deadline. Email confirmation only confirms receipt of the sent documents; it does not indicate a thorough review has been completed. Following review of the submitted HPP Application, the Supportive Services Analyst will provide individualized feedback and/or technical assistance as needed.
